a103	(RF-22, Alt-3) AAAYIP1382 0000263995	0	<p>Anchor Paper 3 Score Point 0</p> <p>Only capitalizes first letter and puts period at end, which is an error as written since the original sentence goes on much further. Doesn't address enough of the original sentence for partial credit.</p>
a104	(RF-04) AAAYIP1382 0000066751	1	<p>Anchor Paper 4 Score Point 1</p> <p>Some corrections made so it can be partial credit. Unlike A-3, this response at least deals with the entire sentence; First word is capitalized, and the period at the end is added. A low-end SP 1.</p>
a105	(RF-06) AAAYIP1382 0000076836	1	<p>Anchor Paper 5 Score Point 1</p> <p>Although the student did not include the dialogue, the student made the stylistic choice to narrate it. This results in a cleaner and more efficient sentence as it is rewritten. The task didn't require them to maintain the spoken dialogue and by taking it out, the student didn't need to punctuate dialogue. The sentence, however, is not entirely correct because it is missing a comma and the tense is changed to present. (It is not SP1 because of the missing dialogue but because of other errors.)</p>
