Introduction

The Religious Society of Friends, or Quakers, was a group founded in England in the 1600s. They were often put in jail because of their beliefs and practices. A Quaker named William Penn moved to America and became governor of Pennsylvania. Penn wanted to establish political and religious rules that differed from the English monarchy. He wrote the Frame of Government, which became Pennsylvania's first constitution.

Analyze the sources about the Quakers in order to investigate the compelling question "How do beliefs affect communities?"



Source 1

This source is about the relationship between William Penn and the government of England in the late 1600s.

The English Parliament passed laws denying basic rights to people who did not follow the rules of the Church of England. These laws affected the Quakers. In 1680, a Quaker named William Penn asked King Charles II for land in America. King Charles owed Penn a debt, so in 1681 he granted Penn's request for ownership of land. Although William Penn became governor of Pennsylvania, King Charles required that the laws in Pennsylvania be similar to laws in England.

Source 2

This source is about the Lenni Lenape, an American Indian tribe who lived in Pennsylvania at the time that William Penn arrived.

William Penn and the Lenni Lenape met under a great elm tree and made a treaty. There are no records from 1683 about this event, but stories of the meeting were passed down. William Penn said, "We meet on the broad pathway of good faith and good-will; no advantage shall be taken on either side, but all shall be openness and love. . . . We are of one flesh and one blood." Tamanend, the chief of the Lenni Lenape, replied, "We will live in love with William Penn and his children as long as the creeks and rivers run, and while the sun, moon, and stars endure."

Source 3

This source is about William Penn's Frame of Government, Pennsylvania's first constitution.

- Laws will be made by a government that includes a governor and an Assembly.
- Members of the Assembly will be elected.
- All persons who live peacefully in society may worship God in the way they choose.
- The Assembly will build public schools. All children who are 12 years old will be taught a useful skill.
- Courts will provide justice, and people may plead their case in court.

William Penn explained to settlers that Pennsylvania would be a place where all types of people would be welcome. Penn had good relationships with the American Indians. He was able to purchase land needed to build the city of Philadelphia from them. The city grew as Quakers began construction of community hospitals, churches, schools, and other buildings. Quakers quickly became leaders in government and business.

Exemplar

The government of colonial Pennsylvania was set up to uphold democratic principles by following the beliefs of the Quakers. Democratic principles include equality, freedom, liberty, and respect for individual rights. William Penn founded the colony based on religious and political freedom. The Quakers believed that all individuals were equal. The Quaker belief of equality made their government more democratic. Individual rights were respected because the Quakers believed that all people should be valued, including the Lenni Lenape American Indians.

William Penn's Frame of Government set down rules for government that would be democratic. It included an elected Assembly to help make the laws, courts where people could plead their case, and freedom of religion. The Quaker belief in equality led to the opening of public schools.

- Penn treated American Indians fairly and had a good relationship with them. (Source 2)

- Courts will provide justice, and people are free to plead their case in court. (Source 3)

The government of colonial Pennsylvania was set up to Uphold democratic principles because they had to respect colonists and make sure all were equal. In source 4 it says, "All peeople are equal and should be valued." This means that the government believes that all people should be valued the same and that they should all equally be treated. My reason for choosing to cite this from the text is because it shows how the government thinks that all people should be equal and valued the same. Therefore the government of Pennsylvania makes sure that all are equal and that they are all treated the same and valued the same way.

Anchor Annotation, Paper 4 Score Point 1

The student response demonstrates completion of only a limited important component: colonial Pennsylvania upheld democratic principles by valuing equality. The response repeats this single concept from Source 4 several times (*This means that the government believes that all people should be valued the same and that they should all equally be treated. My reason for choosing to cite this from the text is because it shows how the government thinks that all people should be equal and valued the same)*.

The government of colonial Pennsylvania was set up to uphold the democratic principles because they wanted religoius beliefs to be different and unique. The student response demonstrates completion of only a limited important component—colonial Pennsylvania upheld democratic principles by being a place where all types of people would be welcome—showing minimal understanding (*In the sources they talk about Pennsylvania and that all types of people and religoins are welcome in Pennsylvania*).
